

PARTICIPANT AGREEMENT

I, as parent or guardian, give my consent to give the prescribed and/or over-the-counter medication(s) listed above to my child during the summer program, in the dosage and schedule given above.

The parent or guardian should give the medication(s) to authorized program personnel in a sealed plastic bag with sufficient instructions in regards to dosage, schedule of administration, and any other pertinent information. Camp staff will not be responsible for administering any medication requiring special training or nursing skills, such as injections for diabetes or allergies. Admissions staff should be notified of any special medical needs to determine if the prospective participant can be accepted into the program. Participants with contagious medical conditions will not be permitted to attend camp.

Please, confirm your acceptance of this Participant Agreement, as parent or guardian, accept this agreement: by clicking on the "I ACCEPT" button back on the sign-up registration form.

By signing below, you agree to all of the following terms and conditions pursuant to which BCN Sports Services Canada Inc., an Ontario corporation ("we" or "us") shall provide the FCB Soccer Camps described in the accompanying brochure. These terms and conditions apply to the FCB Soccer Camp named on the Guest Reservation and Payment Form (the "FCB Soccer Camp") and the program for this FCB Soccer Camp.

By execution of this Participant Agreement, you are acknowledging limiting terms and conditions waiving certain rights at law that otherwise might be available to you.

Reservations:

A completed payment fee per participant, depending on the program chosen (except when otherwise noted in writing by us) and a completed Reservation Form ("Reservation Form") are required with this Participant Agreement to reserve space for FCB Soccer Camp. All prices are in Canadian Dollars. Except as expressly stated in the brochure, you are solely responsible for any FCB Soccer Camp-related costs that you incur.

Client Cancellation & Refund Policy:

If you choose to cancel your reservation, we must receive written notice of said cancellation either via certified mail, overnight courier, or e-mail sent to info@fcbcanada.com

(with confirmation of receipt thereof from us), and you shall be subject to the following cancellation fee schedule: If we receive a written notice prior 90 days of the camp date, the organization will retain \$95.00 as a compensation for the registration expenses. If we receive a written notice between 90-60 days of the camp date, the organization will retain 50% of the

payment fee paid. If we receive a written notice of cancellation within 60 days of the camp date, there will be no refunds of the amount paid for the FCB Soccer Camps. If the participant simply does not show up to the camp, there will be no refunds for the amount paid or equipment shipped to participant.

Cancellation or Substitution:

We may cancel any FCB Soccer Camp at any time for any reason, including without limitation if we deem the number of participants signed up for a given FCB Soccer Camp to be insufficient to operate such FCB Soccer Camp. We will make commercially reasonable efforts to keep the schedule as it has been published; however, the final schedule may vary due to factors beyond our control. We may in our sole discretion substitute services or goods of similar quality for any service or good stated in the schedule. If the FCB Soccer Camp is cancelled, our liability is limited to a full refund of your deposits and FCB Soccer Camp Price, and we will not be liable for any other costs, damages, or refunds of any kind for any loss, delay, inconvenience, disappointment, or expense whatsoever in such circumstances. If for reasons beyond our control, a FCB Soccer Camp in progress must be interrupted or cancelled, we will in good faith consider refunding a portion of the FCB Soccer Camp Price depending on our actual costs incurred compared to the FCB Soccer Camp as originally contemplated.

Certification of Participants Health:

Responsibility to Inform Operator of Disabilities or Pregnancy:

By signing below and/or tendering any portion of the FCB Soccer Camp Price to us, I certify that the participant does not have any condition or disability that would create a hazard for you or others participating in the FCB Activities (as hereinafter defined). I agree to inform you via certified mail or e-mail sent to info@fcbcanada.com (with confirmation of receipt thereof from you) at the time I tender my first payment of the FCB Soccer Camp Fee (or at such later time when I become aware of such a condition) of any existing physical or mental illness, disability, pregnancy or any other condition for which the participant may require medical attention or special accommodation during the FCB Soccer Camp. We make no guarantee to be able to accommodate the participant for such condition during the FCB Soccer Camp, and we make no representations or warranties regarding special accommodations or handicap accessibility at the FCB Soccer Camp.

Athletics Release:

I hereby acknowledge that playing or practicing soccer is a potentially hazardous activity. I agree that the participant is voluntarily entering and assuming all risks associated with participating in those activities, including but not limited to falls, contacts with other participants, the effects of weather including heat and or humidity, and the conditions of the training grounds and facilities, all

risks being understood and appreciated by me. Having read this waiver, and knowing these facts, and in consideration of BCN Sports Services Canada Inc.'s acceptance of this application, I hereby waive and release BCN Sports Services Canada Inc. and its officers, directors, agents, contractors, employees, instructors, trainers, volunteers, members, representatives and all affiliated and related companies from all claims and liabilities of any kind arising out of the participant's involvement in soccer playing, practicing, or training, while registered as a participant and participating in any and all FCB Soccer Camp sanctioned activities, events, practice sessions or social activities at any location (notwithstanding the location where the participant originally registered) (all hereafter collectively referred to as "FCB Activities"), including injury, loss or damage which might be caused by the negligence of BCN.

The participant acknowledges that he/she is aware of the possible risks, dangers and hazards associated with participation in FCB Activities, including all manner of injuries resulting in muscular injuries and soft tissue injuries including bruises, scrapes, cuts, etc., from executing strenuous and demanding physical techniques, collisions with the wall, floor, ground contact with other participants or equipment used by other participants (including ropes, weights and pads) and failure in proper use of the equipment or techniques either by the participant or other participants; and the possible risk of severe or fatal injury to the participant or others.

The participant acknowledges that the participant's risk of injury increases as the participant becomes fatigued.

The participant further acknowledges that such risks may be caused by the participant's own actions or inactions, the action or inactions of others participating in the FCB Activities, the condition in which the FCB Activities take place, or the negligence of BCN.

The participant acknowledges that there may be other risks and social and economic losses either not known to the participant or not reasonably foreseeable at this time.

General Release:

In consideration of BCN allowing the participant or the undersigned's minor child membership and participation in the FCB Activities, The undersigned agrees: (i) to waive any and all claims that the undersigned or the participant has or may have in the future against BCN, its officers, directors, agents, contractors, employees, instructors, trainers, volunteers, members and representatives as a result of the undersigned or the undersigned's minor child's membership and/or participation in the FCB Activities; (ii) to release, hold harmless and indemnify BCN from any and all liability from any loss, damage, injury or expense that the participant may suffer, or that the participant's next of kin may suffer as a result of the participant's membership and/or participation in the FCB Activities due to any cause whatsoever, including negligence, breach of contract, or breach of any statutory or other duty of care, including any duty of care owed under the Occupiers Liability Act (Ontario), on the part of the BCN; and (iii) to release, indemnify and hold harmless any affiliated BCN company, partnership or other person affiliated with BCN including those persons whose property is used for any FCB Activities (collectively, a "Related Third Party"), and each of their respective directors, officers, agents, contractors, employees, instructors, trainers, volunteers, members and representatives from any and all claims, demands, actions and costs which might arise out of the

participants membership and/or participation in the FCB Activities, even though such claims, demands, actions and costs may have been caused by the negligence of such Related Third Party .

Travel Release:

I acknowledge that certain FCB Activities may take place at a location or locations other than BCN premises.

I further acknowledge that: (i) during outdoor trips to other locations, extreme changes in weather or temperatures may result in heatstroke, sunstroke, or hypothermia and where applicable remoteness of location can result in poor communications and inability to get rescue or medical assistance quickly or easily; (ii) in an unfamiliar location, the participant may become lost, get off course or be separated from the rest of the party; (iii) steep or other dangerous terrain may exist where a fall or other accident may cause injury or death; (iv) risks, injuries and/or death that may result from transportation (all modes or types including but not limited to public or private motor vehicle) incidents/accidents; and (v) BCN shall not be responsible for any damages or injury caused by or related to the participation of the undersigned or the undersigned's minor child (children) in any FCB Activity at such location.

If a parent(s) of a minor child (children) has any concerns about transportation to or from an off-site location or any off-site FCB Activity, such parent shall be permitted to accompany such child (children).

No Representation re: Medical Qualifications:

I confirm that I have been advised that BCN does not represent that BCN or any employees or contractors have any level of medical training that would provide assistance to an injured person.

Moreover, BCN does not maintain medical equipment or apparatus (including but not limited to defibrillators or Epi-pens) which could assist an injured or ill person.

In the event that BCN is provided with any medical apparatus by or on behalf of a participant in FCB Activities, BCN makes no representation or warranty that any BCN personnel have the skill or training to operate such medical apparatus appropriately to assist any person or to prevent further injury.

I acknowledge that I am solely responsible to select and purchase adequate medical/health and travel insurance.

No medical/health or travel insurance will be provided by BCN.

In the event of a medical/health or travel related problem, BCN accepts no responsibility for any costs or damages associated with a medical/health or travel related problem nor will BCN pay for any medical/health or travel related expenses, which may be incurred by my participation in the FCB Activities.

Photography and Likeness Release:

I hereby authorize BCN to allow the reproduction, dissemination, and/or publication of my name and/or likeness (or those of my minor child) for media coverage, public relations, advertising, marketing or any other BCN promotional or educational purposes.

This may be done in conjunction with my participation in any FCB Activities and I understand and agree that I may neither pay a fee to receive individual promotional consideration from my participation in the FCB Activities, nor will I receive any payment for the possible commercial use of my name or likeness.

Responsibility/Liabilities

We act only in the capacity of agent for providing services or goods in connection with the FCB Soccer Camp (the "Suppliers"), camp operators, and providers of entertainment. We assume no responsibility for any personal injury, property damage, or other loss, accident, delay, inconvenience, or irregularity which may be occasioned either by reason (1) any act or omission of any of the Suppliers (2) any matter beyond our exclusive control including but not limited to a delay or cancellation of a flight that causes you to miss any portion of the FCB Soccer Camp. We have no special knowledge regarding the financial condition of the Suppliers, unsafe conditions, health hazards, weather hazards, or climate extremes at the camp locations. You are also responsible for respecting the authority and following the directions of the FCB Soccer Camp guide during a FCB Soccer Camp. We may exclude you from participating in all or any part of the FCB Soccer Camp if, in our sole discretion, your condition or behavior renders you unfit for the FCB Soccer Camp or unfit for continuation once the FCB Soccer Camp has begun. Unfitness may include, without limitation, any behavior that, regardless of its cause, is inappropriate or offensive or interferes with the delivery of FCB Soccer Camp services, or may constitute a hazard or embarrassment. In such case, our liability shall be strictly limited to a refund of the recoverable cost of any unused portion of the FCB Soccer Camp. Should you decide not to participate in certain parts of the FCB Soccer Camp or use certain goods included in the FCB Soccer Camp, no refunds will be made for those unused parts of the FCB Soccer Camp or goods. You agree to indemnify and hold us harmless from and against any costs, damages, losses, or liabilities arising out of your actions or omissions.

General:

Any dispute related to the FCB Soccer Camp shall be governed by Ontario law without regard to conflict of laws principles. The federal or provincial courts in Toronto, Ontario shall be the exclusive forum for any lawsuit related to the FCB Soccer Camp, and you consent to the personal jurisdiction by said courts. You agree to present any claims against us within 30 days after the FCB Soccer Camp ends and to file within one year of the incident, and you acknowledge that this expressly limits the applicable statute of limitations to one year. Facsimile transmission or electronic transmission (such as pdf) of any signed document shall be deemed delivery of an original. At our request, you shall promptly provide an original document as well. If there are any conflicts between

this Participant Agreement, the Reservation Form, and the Itinerary, this Participant Agreement shall govern.

Privacy Policy:

In accordance with the Personal Information Protection and Electronic Documents Act (Canada), BCN has adopted a Privacy Policy dealing with the personal information collected by BCN from its customers, clients and employees.

The full text of such Privacy Policy is available at the offices of BCN, by mail.

Special Provisions for Parents or Guardians of Participants

I, the undersigned, as parent or guardian, give my consent for the participant, identified herein, to participate in soccer activities during the camp program. I understand that participation in any soccer event is done at our own risk. I will not hold BCN Sports Services Canada Inc., its officers, agents, employees, or anyone acting in its behalf, responsible or liable for injury occurring to the named participant in the course of such activities or such travel.

I understand that BCN Sports Services Canada Inc. will complete required accident insurance forms, after which all claims under insurance policy, or policies, for injuries received while participating in the program activities and events, shall be processed by the participant, his/her parent(s), or guardian(s) through the company handling the participants insurance claim and not through BCN Sports Services Canada Inc.

I hereby accept financial responsibility for personal items lost by the participant identified herein.

I authorize BCN Sports Services Canada Inc. to transport and to obtain, through a physician of its own choice, any emergency medical care that may become reasonably necessary for the participant in the course of such activities/events or such travel. I also agree that the expenses for such transportation and treatment shall not be borne by BCN Sports Services Canada Inc. I accept full responsibility and hereby grant permission for the participant to travel on any camp-related trip by bus or van.

Illegal Substances:

Notice is hereby given that possession or sale of controlled substances by any participant is grounds for expulsion of the program. Participant possession of or being under the influence of alcoholic beverages, and/or hallucinogenic drugs or combinations of drugs or substances having

hallucinatory effects, marijuana, or under the influence of glue or other drugs or combinations of drugs or drug paraphernalia expressly prohibited by federal, provincial, or local laws, including prohibited substances which shall include those substances possessed, sold, and/or used that are held out to be, or represented to be, controlled substances, illegal substances, or counterfeit in any respect illegal or controlled substances is grounds for expulsion from the remaining of the summer program and referral to proper law enforcement agencies. Parent(s) or Guardian(s) will be immediately notified to pick up the participant. In none of the foregoing cases, shall the fee paid for the program be reimbursed, in whole or in part.

Further notice is hereby given that possession of prescription drugs, or any other over-the counter medication, not specifically ordered for the participant by a physician or the participants parent or guardian is grounds for expulsion from the remaining of the summer program. Parent(s) or Guardian(s) will be immediately notified to pick up the participant. The fee paid for the summer program will not be reimbursed, in whole or in part.
